

BAR UNITED WHISKY PONG TOURNAMENT TERMS AND CONDITIONS

1.0 Eligibility

1.1 The “**Bar-United Whisky Pong Tournament**” is open to **all non-Muslim aged 21 years and above** in Malaysia except employees and immediate family members of Pernod Ricard Malaysia (the “Organizer”), their affiliates, subsidiaries, advertising/PR agencies and suppliers.

2.0 Contest Period

2.1 The Organizer reserves the absolute right to shorten or extend the tournament period if deemed necessary without the need to provide prior notice.

3.0 How to Participate?

3.1 To participate in the tournament, participants are required to:

3.1.1 Have an authentic Facebook account to login.

3.1.2 Successfully eliminate all the (10) cups in the shortest time.

4.0 Judging Criteria

4.1 Winners will be chosen based on the leaderboard standings.

4.1.1 The Organizer’s decision is final, and no further correspondence or appeal will be entertained.

5.0 The Prizes

5.1 Each participant can only win ONE (1) Prize throughout the Tournament Period.

5.2 Top ten (10) winners will be rewarded based on their standings weekly and monthly.

6.0 Notification of Winners

6.1 The Winners’ List will be notified via Facebook Private Message or any other medium deemed appropriate by the Organizer.

6.2 Winners are required to provide their personal details within one (1) day upon receiving the winner's notification message via Facebook Messenger. Failing to do so, entitled prizes will be forfeited and no further claims will be entertained.

6.4 In the event of a dispute, the potential winner may be required to provide proof that he/she is the authorized holder of the identified Facebook account, but the organizer’s decision will be final.

7.0 Rights of the Organizer

7.1 All decisions made by the Organizer in relation to this Event Contest including but not limited to the selection of winners and forfeiture of Contest Prizes (if any) shall be final, conclusive and binding. No correspondence or appeals will be entertained. The selection of the winners shall be in accordance to the Participants’ satisfaction of the Event Contest entry criteria and determined at the Organizer’s sole and absolute discretion.
